- Advisor and Joint Advisors: uppercase and lowercase letters, font size 14, justified. If there is more than one Joint Advisors, the names should be in alphabetical order. Should begin in the lower third of the page. It should be used the title of Doctor Professor for the counselors and to the coorientadores that have the title of doctor.
- Name of the city and year: The last row should have the year of completion of work and in the line before the last the city. In uppercase, font size 14, bold, centered.
